1. Our team will monitor and verify:
    - Instagram follows

  2. Entry via the website **alone does not guarantee a prize**, particularly where the Instagram requirements have not been met.

### 5. Winner Selection Process

1. All valid entries that meet **all entry criteria** will be compiled into a single entry list.
  2. Winners will be selected by a **random draw** conducted after the competition closing date.
  3. The random draw will be carried out using:
    - A reputable **online random selection tool**, or
    - A computer-generated randomisation process
  4. From the pool of valid entries:
